5. In 2007, the Congress passed the "Veterans Disarmament Act" without a recorded vote in either chamber. This legislation disarms hundreds of thousands of military veterans who are suffering from ailments that frequently follow combat stress. The gun ban, therefore, denies veterans their Second Amendment rights not on the basis of the conviction of a crime, but rather on the basis of a doctor's opinion.
